Analysis and Action taken based on the Students' Feedback (collected by IQAC) on Academic Curriculum

### Feedback Analysis:

The feedback on the academic curriculum provided by Students has been thoroughly studied. As per the feedback data, Majority (~90%) of the students of the department of the Forensic Science and Technology are very much pleased with academic curriculum that are taught in both the programme i.e. B.Sc. and M.Sc. Forensic Science They are also satisfied with designed syllabus for both programme in Forensic Science. Furthermore, the syllabus provides glimpses that students need to go through it thoroughly while preparing for competitive examinations. Only a minority number of students (~10 %) are not satisfied with the laboratory facilities available in the department.

### Action Taken Report:

Feedback analysis result of the students of both BSc and MSc programme on design of syllabus is quite satisfactory, so the department does not take any action at this moment regarding the syllabus. Our faculty members already have discussed in one of our DC meeting about the addition of the new subject Forensic Toxicology into the syllabus of M.Sc. in Forensic Science programme and as a specialization. The minor changes required in the curriculum would be taken care of in the future BOS. As it was mentioned by a few number of students (~10%) they were not unsatisfied with the present lab facilities, we have already passed as decision in the last DC meeting for the requisition of lab facility. The necessary chemicals and instruments are already on tender (till date technical tender has been completed) will definitely strengthen our laboratory facilities.
